

# S. 127: THE WRONG PRESCRIPTION AT A HIGH PRICE

Inflation is at record highs and drug companies are pushing their prices higher. American patients need relief and can't afford policies that would push drug costs higher.

Congress is considering legislation that would undermine patients' pharmacy benefits. Analysis has found that

S. 127 would add ten billion dollars or more to the annual federal deficit, and cost the U.S. economy tens of billions more.

## The High Cost of S. 127

University of Chicago Professor Casey Mulligan recently testified before Congress on the high cost that S. 127 would have for patients, taxpayers and businesses:

- Provisions of S. 127 may increase drug costs for brand drugs by as much as 52%.
- The bill's requirements may push American patients' premiums higher by as much as 31%, as Americans already struggle to afford the cost of living.
- Other provisions of the bill may have the effect of pushing patients off critical medications they rely on, like insulin.
- S. 127 could cost up to \$48 billion by reducing competition in the health care market.
- In quantifying the bill's pharmacy DIR restrictions, Mulligan estimated that S. 127 would add between \$8 billion and \$11 billion to the federal deficit every year.
  - He wrote, "Disclosure requirements could impose tens of billions of dollars in annual net costs by discouraging competition among manufacturers, among pharmacies, and among PBMs."

### What Stakeholders Are Saying

- Ike Brannon, Senior Fellow, Jack Kemp Foundation: "Congress should drop its attacks on Americans' pharmacy benefits and look for genuine solutions to the high prices of prescription drugs that aren't thinly disguised favors for stakeholders."
